## Girl, 15, Named; Meyer Hospital Tests Are Next

A 15-year-old North Buffalo girl, described by police as a "very logical and prime suspect" in the kidnapslaying of Andrew T. Ashley, was identified last night by two children as their abductor.

The girl, Chyrel Jolls of 21 Leroy Ave., was "positively" identified by Richard Edgington, 5, of 81 Saranac Ave. and Susan Benedict, 5, of 299 Tacoma Ave., as the girl who abducted them before the Ashley abduction-

The girl's mother, Mrs. Georgia Jolls, appeared at Police Headquarters shortly after midnight and signed papers authorizing her daughter's confine-ment to Meyer Memorial Hospital for psychiatric examination.

Chryel was still being questioned at Headquarters shortly before 2 this morning. Authorities said she would be taken to the hospital shortly.

The teen-ager was interviewed for nearly seven hours at Headquarters by a psychiatrist, Dr. Samuel Yochelson.

Det. Chief John J. Whalen said a witness placed the girl at the scene of the Ashley murder in Delaware Park before and after the crime. He did not reveal the name of the witness.

Whalen said the girl has a history of mental illness and has been confined in at least two mental hospitals: She was not charged, pending further investigation.

Police Commissiner Frank N Felicetta, Dist. Atty. Carman F. Ball and Mayor Frank A. Sedita were at Headquarters during the investigation. Police will consult with Ball's office today on the matter of placing charges against the girl.
