Andrew T. Ashley one day after the Edgington abduction.

However, neither the Ashley murder nor the kidnaping of another 5-year-old, Susan Benedict, last April 23, is mentioned in the warrant.

Chyrel, 15, has been considered by police as a prime suspect in all three cases since Monday, when she was taken into custody for the third time.

#### Three Cases Cited

The Ashley boy's body, bound and gagged, was found floating in Delaware Park Lake June 25 The Edgington boy had been led by his abductor on a tour through the park before he was left bound and gagged in a rail-road right-of-way June 22. The Benedict girl, who lives at 299 Tacoma Ave., was left bound and gagged near some railroad

tracks April 23.

Dist. Atty. Carman F. Ball advised issuance of the Edgington kidnaping warrant at the conclusion of a lengthy meeting in his office last night.

"In the cases involving the killing of Andrew Ashley and the kidnaping of Susan Benedict, I advised them (the police officials) that at this stage of the investigation I do not feel there is sufficient evidence to secure a warrant for her ar-

#### 31/2-Hour Conference

The top-level conference at County Hall lasted 31/2 hours, Chyrel's 14-year-old sister, Norma, was taken into the conference room during the session, but no explanation for her appearance was given. Another girl, believed to be a cousin, also was interviewed.

Attending the session were Commissioner Felicetta, Detective Chief Whalen, Assistant Detective Chief McCarthy and Lt. Thomas Hennessey.

Earlier, at Police Head-quarters, Whalen said he was "positive" that Chyrel was the mystery woman who took Andrew Ashley from in front of his home at 195 Jewitt Pky.

Felicetta said the investigation is still centered around the Jolls girl. Whalen said the evidence gathered, while not enough to secure a murder warrent, still makes her "the prime suspect."

### Crude Map Captioned

The crudely-sketched map re-covered by police in Chyrel's home was captioned: "The way I went last Friday." It traced a path from the girl's home to Delaware Park Lake and back—a path which took her by the Ashley home. Police believe the Friday was June 23, the day Andrew was abducted and murdered.

Whalen's opinion was echoed by McCarthy, who is head of the Homicide Bureau. Both officers also expressed the belief that Chyrel was responsible for the Benedict abduction two months earlier.

Also examined was a book entitled "Claudia & David," by Rose Franken, which police said contained several marked passages about people falling into water and drowning, and several more notations about strangulation using a plastic bag.

The abductor of Richard Edgington wrapped his head in A plastic cleaning bag, but holes in the bag kept the boy from suffocating.

Also found was a pencil-scrawled beginning of a letter. The letter, addressed to an unidentified clergyman, is reported to have begun:

"Dear Rev. am writing because I am in trouble and would like to talk..." The letter and the sentence were apparently never finished.

Two color pictures, clipped from a brush company catalog, were found in Cheryl's room. The pictures portrayed a man washing a baby in a small tub, and another domestic scene with a father and an infant. Other Items Examined

Police closely examined other items found in the Jolls home, in addition to the crude map.

The other items included two sheets of paper, of the type used by school children for yesterday gave a statement to police. In it, she reportedly said Chyrel, who occasionally stayed at the Ott home weekends took one of her children for a walk and later reported the child missing.

Mrs. Ott said her child, a small boy at the time of the incident few years ago, was later found bound hand and foot in a small rear room of the Ott home. Chyrel denied she tied the boy, but Mrs. Oft told po-lice she was sure the firl had done so.

Mrs. Ott also said the girl became violent on one occasion when told there was no mail from her father, hospitalized at the time.

Chief Whalen said psychiatrists have reported the girl, if she is guilty of the murder and abductions, may never admit them because "it is entirely possible she consciously may never remember them."

Whalen said he questioned the girl at great length and found her to be antagonistic. He said she showed no emotion when she looked at photos of Andrew Ashley's body on the banks of the lake, but turned and said:

"What am I supposed to do-

Chyrel, who recently completed seventh grade at School 54, is about three years behind her age group. She has received treatment for mental illness at Strong Memorial Hos-pital, Rochester; Newark State Hospital and the Good Shepherd Home.

## FBI Report On Lab Test Is Received

## Girl to Face Kidnap Charge

The Federal Bureau of Investigation said last night that hair strands found in the play helmet of abducted 5-year-old Richard Edgington have the same characteristics as Chyrel Jolls'

The report from the FBI laboratory in Washington, D.C., was made as Buffalo police assembled evidence to obtain a warrant charging Chyrel with kidnaping Richard on June 22.

The warrant will be sought in City Court this morning in the wake of a lengthy conference of police officials and the district attorney's office yesterday.

The FBI report said the hair strands found in Richard's helmet have the same characteristics as Chyrol's hair, but added that they could match identical nair characteristics from another

Buffalo police, however, accepted the FBI report as further evidence in their case against the 15-year-old North Buffalo girl.

Police believe the call referred to was the one the girl admitted making before the boy's body was found. She was apprehended at that time by FBI agents, who had put a tracer on the Ashley phone shortly after the boy was reported missing.
